**Completion of the VI 1 form**

- 1) VQA Ontario and LCBO will complete and add certifying marks to sections 1, 10, 11 and 15 of the VI 1 form.
- 2) The partly completed original copy of the VI 1 form will be picked up by the winery to accompany shipment.
- 3) The winery must fill in the remaining applicable sections and provide the original to customs at the point of entry.
- 4) **It is the winery's responsibility to ensure the wine complies with EU requirements.**
- 5) Please allow 3 weeks to complete the certification process. (Please advise us in advance if you have shipping deadlines to meet and we will make our best efforts to expedite the certification.)
